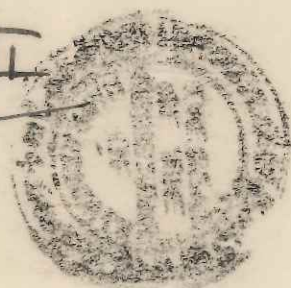

The Trustees shall be entitled to invest the donations received in any manner on whether movable or immovable properties and shall also be entitled to deposit the amount at a fixed rate of interest with any scheduled Bank or in any Business establishment. The Trustees shall be entitled to carry on any business held in Trust by them for augmenting the resources of the Trust, including carrying on business in Partnership.

13. All amounts received shall be deposited with the bankers of the Trust regularly, after keeping only small amounts to meet day to day expenses.

14. The Trustees are empowered to borrow money with or without security and utilise the same for the benefit of the Trust and pay interest on such borrowings and the Trustees shall repay as early as possible such borrowings out of the income and also from out of the donations received.

15. The funds of the Trust including the interest shall not be utilised for any other purpose other than the objects mentioned herein and the conditions will bind the Trustees.
